The Kern County Sheriff's Office is in receipt of your request dated April 1, 2015..

You requested:

- The sole source justification documentation for the purchase of "specialized radio equipment system from Digital Receiver Technology".

The Kern County Sheriff's Office, Finance Unit, conducted a search of their records and did not locate any of these requested financial documents pertaining to the Digital Receiver Technology. The Finance Unit personnel advised that per the Records Management Guidelines these documents would have been destroyed according to California Government section 26202.

- The invoice and "sole source purchase order with Digital Receiver Technology for the acquisition of one (1) specialized radio communications system in an amount not to exceed \$195,925."

Attached please find a redacted copy of the April 8, 2009 quote from DRT. The Quote has been redacted pursuant to California Government Code section 6254 (k) and 6254.15 as the unit and extended price of each item is DRT's proprietary information (also exempt un the Freedom of Information Act (FOIA) (5 U.S.C.A. 552(b)(4)). The Kern County Sheriff's Office, Finance Unit, conducted a search of their records and did not locate any additional requested documents pertaining to the Digital Receiver Technology "sole source purchase order," as per the Records Management Guidelines such documents would have been destroyed according to California Government Code section 26202.
