The San Bernardino County Sheriff's Department ("Department") received your Public Records Act request on March 4, 2015, and forwarded it to our office for handling. In your request, you seek: "The non-disclosure agreement between the San Bernardino County Sheriff and the FBI concerning cellular telephone surveillance and monitoring equipment from Harris Corporation (KingFish, StingRay, Hailstorm, etc.) or Boeing (DRTBox);" "Any MOU/agreement for sharing/use of cellular telephone surveillance and monitoring equipment;" "Harris Corporation or Boeing Company Terms and Conditions;" "Any notifications about public records act requests regarding StingRay, KingFish, Hailstorm or other Harris equipment or Boeing Company equipment sent by the San Bernardino County Sheriff to the Federal Bureau of Investigation (FBI) since January 1, 2012 and responses from the FBI since January 1, 2012;" and "Any notifications about public records act requests regarding StingRay, KingFish, Hailstorm or other Harris equipment or Boeing Company equipment sent by the San Bernardino County Sheriff to the Harris Corporation or Boeing Company since January 1, 2012 and responses from the Harris Corporation and Boeing Company since January 1, 2012."

Pursuant to California Government Code §6253, subdivision (c), we are requesting an extension of fourteen (14) days to review your request. We will contact you again on or about March 30, 2015, and provide you with an update on the status of your request.
