Subject: Public Records Act Request

Dear Mr. Katz-Lacabe:

This letter follows up on my letter dated March 26, 2015, sent in response to your Public Records Act request, dated February 23, 2015, and received by the Ventura County Sheriff's Office (the "Sheriff") on March 2, 2015.

In my March 26<sup>th</sup> letter, I mistakenly stated that the Sheriff did not have any records responsive to the third category of documents you requested: Harris Corporation or Boeing Company Terms and Conditions. The Sheriff has identified two documents that are titled Harris Government Communications Systems Division Terms and Conditions of Sale for Wireless Equipment, Software and Services ("Harris Terms and Conditions"). The contents of those documents, however, are exempt for the same reasons as the non-disclosure agreement. The explanation of those reasons are set forth in my March 26<sup>th</sup> letter.

As such, the Sheriff will produce copies of the Harris Terms and Conditions, but redact the contents that are exempt pursuant to Government Code sections 6254, subdivision (k) and 6255, and pursuant to Evidence Code section 1040 and 1060. We apologize for not including these documents with our initial response.

The persons responsible for the determinations above are Emily T. Gardner, Assistant County Counsel, and Tracey Pirie, Sheriff's Bureau Manager. Any further questions or communications on this matter should be directed to the undersigned.

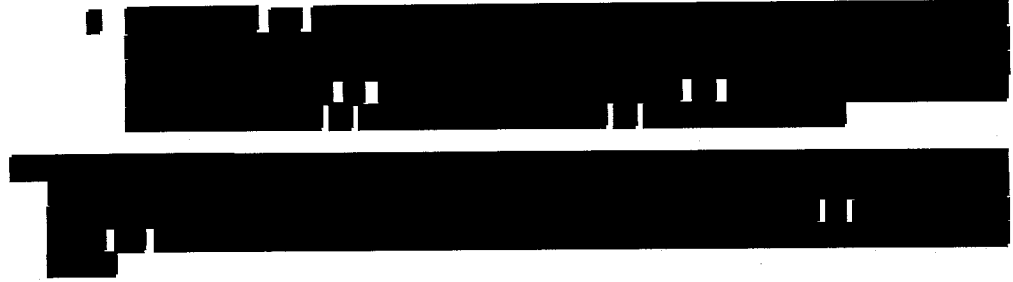

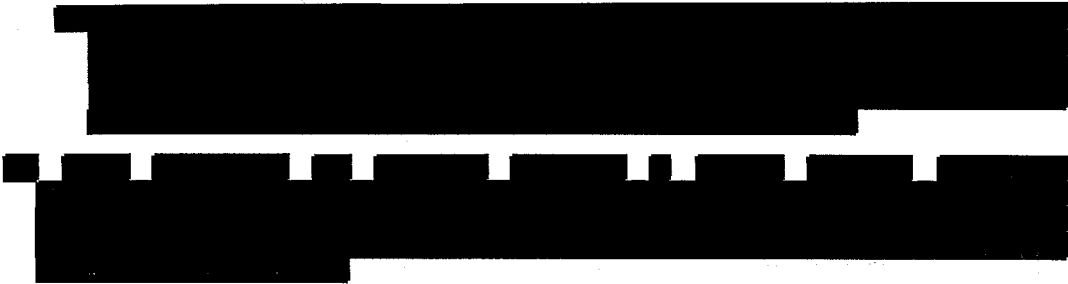
